1.2.2.1	Non-payment of membership fee	
	Members were reminded to continue pay their fees on time so as the Association maybe able to settle the liabilities. In turn, members insisted the Association Council to continue reminding members to pay their fees on time.	
	Agreement: The council was advised to come up with the better strategy to remind members to pay their membership fees.	
1.2.2.2.	Formulation of Financial Policy	
	Members were informed that financial policy is ready, and it is readily uploaded in the Association's website. Members were encouraged to visit the website to read it.	

1.2.2.3 Unit Tittle Delivery

In the last year AGM, there was concern on the delay of unit tittle delivery and members working in those authorities dealing with tittle delivery were advised to fast truck the process.

Agreement: Arepta Council to meet with responsible authorities to discuss this concern and report this feedback in the next AGM.

1.2.2.4 | Status on Review of Housing Policy

It was reported that the review is in final stage and the final draft will be shared to the members through AREPTA's Council.

Agreement: President to follow up immediately with the Ministry of Land and Human Settlements for updates.

1.2.2.5. Co-operation between AREPTA and Valuation Registration Board (VRB)

Members aired out their concern as to whether AREPTA and VRB have a good working relationship and if they do co-operate in their operations, much as the professional fraternity is concerned.

Agreement: It was responded by the AREPTA Council that the cooperation among two professional umbrellas, have improved and that AREPTA will submit request to VRB to request for the inclusion of AREPTA AGMs in CPD units to its attendees and offer CPD programs that will be vetted by VRB.

AREPTA members appreciated the good relationship among these two organs.

1.2.3 Formation of Women Forum in Real Estate (WFRE)

The brief on the mission and objective of the forum was presented. Members were allowed to give their opinions on the matter. Some members doubted that the formation of women forum would weaken AREPTA while others appreciated that the forum to be formulated as will help to create awareness among the women to join AREPTA. Upon long discussion on the matter decision was made through voting whereby the Chairperson asked those who support the forum to be approved to say "YES" and those to disapprove to say "NO". Majority said "YES".

Agreement: it was resolved that the Women Forum in Real Estate to be formulated. That AREPTA Council

should handle the matter appropriately.

It was discussed that despite the submission of the papers about PFM and REFI until now professionals in PFM and REFI are not yet recognised in the Government Service Scheme. It was agreed that AREPTA in cooperation of VRB leaders will continue to work on it including pushing for enactment of RERA which was delayed because of the absence of Housing Policy. Meanwhile Chief Valuer promised to make follow up with UTUMISHI to see what is going on and the CV promised to give feedback to the AREPTA Council.

Agreement: AREPTA Council to seek audience with VRB to discuss on the agenda.

2.2.5 **AREPTA's Plot development at Dodoma**

It was discussed that AREPTA through its Council should develop the proposal on project and the way to finance that project.

Agreement: AREPTA through its Council should engage professionals to perform market survey analysis and come up with the detailed reported on the type of the investment and the methods to finance such investment. It was resolved that AREPTA Council will work on it and give feedback in next AGM.

Agreement: it was discussed and agreed that from 01st January 2022 membership fee will change as follows: Individual membership fee will be TZS 100,000/= Company membership fee will be TZS 300,000/=
